PLEDGE OF ALLEGIANCE

CALL TO ORDER: Regular meeting of the Board of Trustees was called to order at 7:00p.m. by President Tina Shingleton.

ROLL CALL: Clerk called the roll of the Village Board: Trustees Hilliard, Pitcher, Allen, Ross, Dalton, and Wolff, were present.

APPROVAL OF MINUTES: President asked for a motion to approve the minutes from the last meeting. Trustee Wolff made a motion to accept the minutes from the last meeting. It was seconded by Trustee Dalton. Voice vote. All members present at roll call voted yes. Motion carried.

CITIZEN'S HEARING: Russ Kramer to observe.

PETITIONS AND COMMUNICATIONS: Christmas card received from legal counsel's office.

CLERK: Clerk presented the questionnaire for municipalities from the Jackson County Solid Waste & Recycling Management Plan. The questionnaire asks for feedback regarding the biggest waste and recycling issues for our municipality in the next 5 to 20 years. Board discussed. Trustee Wolff suggested better communication between organizations and municipalities regarding recycling events. For example, when Southern Illinois University puts on an event for collecting/recycling hazardous waste, notification of the event could be sent to area municipalities to help them be better informed regarding the upcoming event, and residents can be informed, as well. Collection and disposal of old tires, old furniture and appliances was also a concern. Clerk will mail the completed questionnaire back to Jackson County Solid Waste & Recycling Management Plan office.

TRUSTEES: Trustees Hilliard and Pitcher wished everyone Happy Holidays, and Merry Christmas. Trustee Wolff reported that Dan and Randy did an excellent job taking out the 2 dead trees next to McGuire Road Extension. Trustee Ross advised that she has been keeping up with monitoring the traffic on Baptist Hill Road, such as the deer hunting count and the probability of the number of hunters who used Baptist Hill Road to enter and leave Giant City State Park. Trustee Ross advised that Port-A-Potties have been reserved for the Eclipse. Trustee Dalton asked if she should call Ameren regarding tree limbs on Church Street that are hanging on the electrical wires. President advised that she should. President advised she had received the rental agreement from the 4-H Club for use of the B.C. Ross Community Center. They will be using the Center for their meetings on the 2nd Monday of each month through May 13, 2024.

NEW BUSINESS: Trustee Hilliard reported that he has purchased two signs for the B.C. Ross Community Center, that say No Smoking and No Vaping, he will put these up on the outside of the glass and take down the old signs that are on the inside. Trustee Ross suggested that some of the tables and chairs at the B.C. Ross Community Center be put away up on the stage and only used when needed. It would help reduce the time needed to clean up after an event. President Shingleton

suggested that the doors at the Community Center need draft stoppers, to keep bugs and cold air out. Board agreed.

Board reviewed meeting calendar for 2024 and confirmed the dates. Meeting calendar will be posted at the Village Hall and Post Office.

GENERAL ANNOUNCEMENTS: Trustee Ross announced that there was going to be a potluck on December 15th at the Boardwalk, with music in Studio B. The event begins at 3 p.m.
